ARTICLES OF INCORPORATION OF MICHAEL P. RUDD, P.A.

AHASSEE, FLORIDA The undersigned subscriber to these Articles of Incorporation, each a natural person, competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida, Florida Statutes 621.01 et. seq., and the corporation so formed shall be a professional services corporation for profit.

<u>ARTICLE I - NAME, OFFICE & MAILING ADDRESS</u>

The name of the corporation shall be: MICHAEL P. RUDD P.A., located at 2300 NEW WORLD TOWER, 100 N. BISCAYNE BLVD. MIAMI, FLORIDA 33132.

ARTICLE II - TERM OF EXISTENCE

This corporation is to exist perpetually and shall commence at the time of filing these Articles.

ARTICLE III - NATURE OF BUSINESS

The general nature of the business to be transacted by this corporation shall be the practice of LAW which the individual rendering these professional services is duly licensed and/or regulated.
