**ARTICLES OF INCORPORATION**

The Undersigned Incorporator, for the purposes of forming a corporation pursuant to Chapter 607 of the Florida Statutes, does hereby adopt the following Articles of Incorporation:

**ARTICLE I - NAME**

The name of the Corporation shall be: LLOYD H. GOLBURGH, P.A.

**ARTICLE II - PRINCIPAL OFFICE**

The principal place of business and mailing address of this Corporation shall be 11813 SW 54<sup>TH</sup> Street, Cooper City, Florida 33330.

**ARTICLE III - CAPITALIZATION**

**ARTICLE VI - DIRECTORS**




