ARTICLES OF INCORPORATION

ARTICLE ONE

The name of the corporation is STRIATIONS, INC.

ARTICLE TWO

The period of its duration is perpetual.

ARTICLE THREE

It is the intent of the incorporator that the corporation will qualify under section 1244 of the Internal Revenue Code and that the corporation will file as an "S" Corporation.


