**ARTICLES OF INCORPORATION
OF
DESIGNERS ARCHITECTURAL GROUP, P.A.**

THE UNDERSIGNED, acting as sole incorporator of DESIGNERS ARCHITECTURAL GROUP, P.A. under Chapter 607 of the Florida Statutes, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
NAME AND PURPOSE**

The name of the corporation is DESIGNERS ARCHITECTURAL GROUP, P.A. The purpose of the Corporation is to render architectural services.

**ARTICLE II
SHARES**

The number of shares which the corporation shall have authority to issue is Ten Thousand (10,000), consisting of a single class of common stock, one cent (\$.01) par value per share.

**ARTICLE III
PRINCIPAL OFFICE**

The address of the Principal Office of the corporation is 100 Venetian Court, Sanford, Florida 32771-9546. The location of the Principal Office shall be subject to change as may be provided in bylaws duly adopted by the Corporation.

**ARTICLE IV

**ARTICLE VI
INITIAL BOARD OF DIRECTORS**

The number of Directors constituting the initial Board of Directors of the corporation is two (2). The number of Directors may be increased or decreased from time to time, but in no event

shall the number of Directors be less than one (1). The name and address of the persons who are to serve as the initial Directors until the first annual meeting of the shareholders of the corporation or until successor Directors are elected and shall qualify are as follows:


