# ARTICLES OF INCORPORATION OF:

# ARTICLE I - NAME

The name of this corporation is: F. & M. CAFETERIA, INC.

## ARTICLE II - DURATION

This componation is to exist perpetually. It shall commence its existence upon the signing of these Articles of Incomponation by the initial subscribers.
