AMENDMENT ARTICLE I

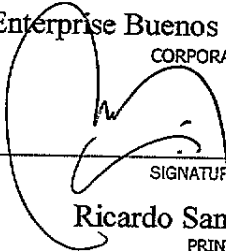
The name of the Corporation is changed to:
