ARTICLES OF INCORPORATION
OF

The undersigned does hereby act as incorporator in adopting the following Articles of Incorporation for the purpose of organizing a corporation for profit, pursuant to the provisions of the Florida Business Corporation Act.

ARTICLE I
Name

The name of the corporation shall be Grady Grafx2 Ink, Incorporated.

ARTICLE II
Principal Office

The principal place of business and mailing address of the corporation shall be 707 River Heights Avenue, Tampa, Florida 33603.

ARTICLE III
Purpose and Powers

The purposes for which the corporation is organized shall be to engage in any lawful business for which corporations may be organized under the Florida Business Corporation Act and shall have all of the general powers granted to corporations organized under the Florida Business Corporation Act.

ARTICLE IV
Duration

The duration of the corporation shall be perpetual.

ARTICLE V
Shares

The number of shares that the corporation is authorized to issue is 10,000, all of which are of a par value of one dollar (\$1.00) each and are of the same class and are Common shares.




