# ARTICLES OF INCORPORATION OF M.G. AUTO SERVICE, INC.

The undersigned subscribers to these Articles of Incorporation, each a natural person competent to contract, hereby associate themselves together to form a corporation under the laws of the State of Florida.

#### ARTICLE I - NAME

The name of this corporation is M.G. AUTO SERVICE, INC.


