In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, hereby acts as an incorporator in adopting and filing the following articles of incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME

The name of the corporation is 1087 BENEVA TOWER, INC.

ARTICLE II - DURATION

This corporation shall have perpetual existence.

ARTICLE III - PRINCIPAL OFFICE

The street address of the principal office of the corporation is 678 Mourning Dove Drive Sarasota, Florida 34236.

ARTICLE IV - PURPOSES

The purposes for which the corporation is organized are:
