CORPORATE NAME

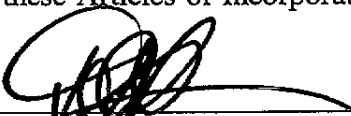

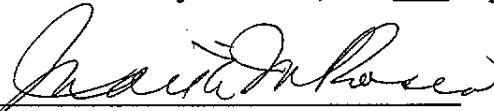
