ARTICLE I

**NAME:** The name of this corporation is

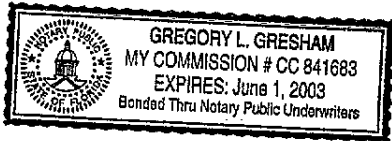


