ARTICLES OF INCORPORATION

OF

(A FLORIDA CORPORATION)

I, the undersigned, hereby make, subscribe, acknowledge and file these Articles of Incorporation for the purpose of becoming a corporation for profit under the laws of the State of Florida and do hereby further certify that have become such corporation under and pursuant to the following Articles of Incorporation:

ARTICLE I

The name of the corporation is:
