THIRD: The date of the adoption of this amendment is the 14 May 2002.

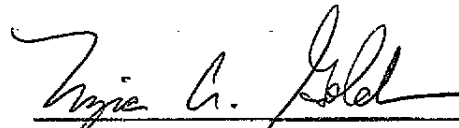
