

THIS IS TO CERTIFY that there is hereby organized a corporation under and by virtue of Florida Statutes section 607.164, et seq., the "Florida General Corporation Act."

FIRST, the name of the corporation is Techteam Associates, Inc., and its initial principal place of business shall be 2101 North Palm Circle, Juno, Florida, 33408.
