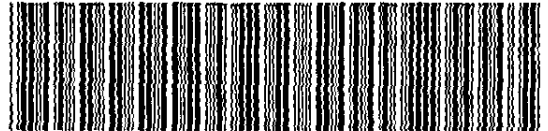

Pursuant to the provisions of Section 607.0124 of the Business Corporation Act of the State of Florida, this corporation files these Articles of Correction within 30 days of the filing date of the document being corrected.

These articles of correction correct the Articles of Amendment to Articles of Corporation of Speedemissions, Inc. filed with the Department of State on December 8, 2005 and originally to be effective January 4, 2006.

The effective date of the Articles of Amendment to Articles of Corporation previously filed was incorrectly stated as January 4, 2006, but should have been January 20, 2006.

The corrected statement in Article IV - Capital Stock, reads as follows:

"Effective January 20, 2006, the issued and outstanding shares of common stock of Speedemissions, Inc. shall be subject to a 1-for-10 reverse stock split. Fractional shares will be rounded up to the next whole share."
