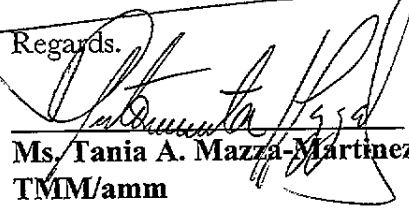

“The name of the corporation is **F. GONZ. CORP.**”

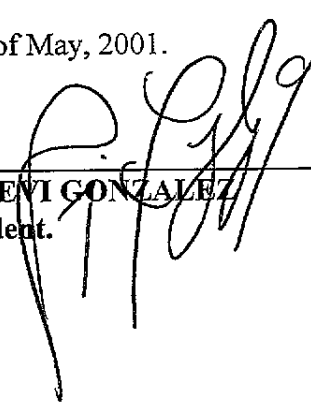
