

ARTICLES OF INCORPORATION

The undersigned hereby makes, subscribes and organize and incorporate a business for profit under the laws of the State of Florida Statues, Chapter 607.

ARTICLE I - NAME

The name of the corporation is BBQ GROUP, INC.

ARTICLE II - NATURE OF BUSINESS

The general nature of the business is a take-out restaurant.

ARTICLE III - DURATION & EXISTENCE

The duration of this corporation shall be perpetual. Corporate existence shall commence immediately upon the subscription and acknowledgement herein to be followed by the filing of the Articles of Incorporation to the Department of State within the five days as allowed by Florida Statue 607.167.

The amount of capital with which this corporation will begin business shall be not less that Five Hundred Dollars, (\$500.00).
