The Undersigned Herby adopts the following Articles of Incorporation for the purpose of forming a corporation under the laws of the State of Florida:

ARTICLE I Name and Principal Office

1.01 The name of the corporation is Merrill & Linda Lund, L.M.T. Inc.

1.02 The principal office of the corporation is, 5730 Marimin Dr., Bonita Springs, FL ,34135

ARTICLE II Commencement and Duration

Shares of capital stock may not be issued until the full amount of the consideration therefore has been paid; thereafter, such shares shall be deemed to be fully paid and nonassessable.

ARTICLE V Preemptive Rights

Each shareholder of the corporation shall be entitled to full preemptive rights to purchase any unsigned or treasury shared of capital stock of the corporation and any securities of the corporation convertible into or carrying a right to subscribe to or acquire any unissued or treasury shares of capital stock.
