The undersigned incorporator, for the purposes of forming a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation.

ARTICLE I.

NAME

The name of this corporation is: FLORIDA RADIOLOGY CONSULTANTS, P.A. (the "Corporation").

ARTICLE II.

PRINCIPAL OFFICE

The principal place of business and mailing address of the Corporation shall be:

ARTICLE III.

EFFECTIVE DATE

The Articles of Incorporation shall be effective as of April 20, 2001.

ARTICLE III.

PURPOSE

The Corporation is organized for the sole and specific purpose of rendering professional medical services. The Corporation shall be authorized to transact any or all lawful business as provided by Chapter 621 of the Florida Statutes, the Professional Service Corporation and Limited Liability Company Act, as it exists on the date hereof or as it may hereafter be amended.

ARTICLE IV.

CAPITAL STOCK

The maximum number of shares of stock that the Corporation is authorized to have outstanding at any one time is one thousand (1,000) shares of common stock having \$1.00 par value per share.

ARTICLE V.
REGISTERED OFFICE AND AGENT

ARTICLE VI.
TERM OF EXISTENCE

The Corporation is to exist perpetually unless dissolved according to law.

NUMBER OF DIRECTORS

The business of the Corporation shall be managed by a Board of Directors consisting of not fewer than one (1), the exact number to be determined from time to time in accordance with the Bylaws.
