I apologize for not filing an annual report. The reason is that this has been the first year of my corporation's existence, and I was unfamiliar with this requirement.

I received your Notice of Revocation more than a week ago, and I was very distressed to learn about the steep fee for reinstatement. I hope would consider waving the \$ 600 fee, as I did not receive the previous UBR notices that your letter talks about. This is probably due to a mix up in the mail because of the fact that I have been in the process of moving to my present business address.

I apologize for not sending out a moving notice before, and I hope that you can be lenient in waiving the \$ 600 fee, since my business is still struggling to survive and master the requirements of doing business. As a consequence it did not turn a profit during its first year of operation, so a 600-dollar cost would weigh heavily on the budget, especially in view of a recent unrecoverable financial loss due to a theft of equipment that is causing a cash flow problem at present.

I am enclosing, at least, a **\$ 150.00 payment** for the Annual Report Fee and the Corporate Supplemental Fee. Also included is the **Application for Reinstatement**.
