ARTICLES OF INCORPORATION
of
LONE STAR TRANSPORTATION AND COURIER, Inc.
A FLORIDA CORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the laws of the State of Florida, hereby adopts the following Articles of Incorporation.

ARTICLE I
CORPORATE NAME

The name of this corporation is: Lone Star Transportation and Courier, Inc., a Florida Corporation.

ARTICLE II
NATURE OF BUSINESS

The nature of the business will be to operate a transportation and courier service, and this is not limited to, doing all and everything necessary and proper for the successful operation of this corporation and for the protection and benefit of this corporation.

This corporation shall have perpetual existence commencing upon five (5) business days prior to the date of the filing of these Articles of Incorporation.

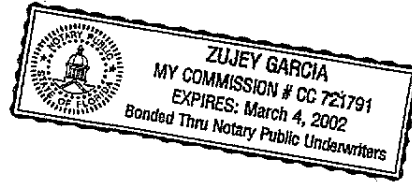
