This letter is to request reinstatement of "Class A Contracting, Inc." (F.E.I.N. #65-111153), as an active corporation. This corporation was administratively dissolved October 4, 2002 for non-filing of the required "2002 Uniform Business Report (UBR)".

After speaking to a representative of the Division of Corporations about how this happened, I am also requesting that the late filing fee be waived as I have not received either the first notice nor the second notice requiring filing. The first I knew of this oversight was when I employed "Contractor's Reporting Services" for changing my General Contractor's License from one business entity to another, on October 11, 2002. They performed a search and informed me of the problem. I immediately attempted to file on-line, but that service is no longer provided on-line.

I was able to obtain an application for corporate reinstatement and that form is attached. I am assuming that 2003 forms will be sent to the correct mailing address as indicated on this application. If there is any way to expedite this request, I would greatly appreciate your help. Application for licensure change cannot commence with the Department of Business and Professional Regulation, until this corporation is reinstated. Thank you in advance.
