The name of the corporation is A.J. HOLLOWAY, P.A. The original Articles of Incorporation for the corporation were filed on May 23, 2001, effective on May 21, 2001, and assigned Charter No. P01000051443.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Statutes, A.J. HOLLOWAY, P.A., adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation is hereby deleted in its entirety and replaced with the following:

**"ARTICLE I  
NAME AND PURPOSE**

The name of the Corporation is **A. J. HOLLOWAY, INC.** The Corporation's purpose shall be general in nature and consistent with Section 607, Florida Statutes."

2. The Amendment to the Articles of Incorporation was adopted by the Board of Directors on July 20, 2001.

3. The Amendment was adopted by the board of directors without shareholder action and shareholder action was not required.

4. This Amendment will be effective as of the date of filing with the Florida Department of State.
