ARTICLES OF AMENDMENT _ TO THE ARTICLES OF INCORPORATION OF CHEROKEE TANK LINES, INC.

Pursuant to the provisions of Sections 607.1003 and 607.1006 of the Florida Business Corporation Act (the "Act"), the undersigned corporation, Cherokee Tank Lines, Inc., a Florida corporation (the "Corporation"), hereby adopts the following Articles of Amendment (this "Amendment").

- 1. <u>Corporate Name</u>. The current name of the Corporation has been and is "Cherokee Tank Lines, Inc.".
- 2. <u>AMENDMENTS ADOPTED</u>. This Amendment provides for the Corporation's change of name.

3. TEXT OF AMENDMENT.

Article I of the Articles of Incorporation, entitled "Name", is hereby deleted in its entirety and the following Article I shall be substituted in for Article I:

ARTICLE I - NAME

The name of the Corporation is "Cherokee Transport, Inc.".
