ARTICLE I. NAME

NAME: The name of this corporation is JAROL ENTERPRISES, INC.

ARTICLE II. DURATION

This corporation shall have perpetual existence, commencing on the 23rd day  
of May, 2001.

ARTICLE III. PURPOSE

This corporation is organized for the purpose of owning, leasing and renting  
properties and transacting any and all other lawful business in the State of Florida and the  
United States of America.

ARTICLE IV. CAPITAL STOCK

This corporation is authorized to issue 100,000 shares, both voting and non-voting  
stock with a par value of (\$.01) common stock. Prior to the issuance of the shares of these  
two classes, the preferences, limitations and relative rights of each class shall be described in  
the Articles of Incorporation by amendment, pursuant to Section 607.0602(4), Florida  
Statutes.

ARTICLE V. PREEMPTIVE RIGHTS

Every shareholder, upon the sale for cash of any new stock of this corporation of the  
same kind, class or series as that which he already holds, shall have the right to purchase his  
pro rata share (as nearly as may be done without issuance of fractional shares) at the price at  
which it is offered to others.

ARTICLE VI. INITIAL REGISTERED OFFICE AND AGENT

The street address of the initial registered office and initial principal office of this  
corporation is 1326 West North Boulevard, Leesburg, Florida 34748 and the name of the


ARTICLE X. INDEMNIFICATION

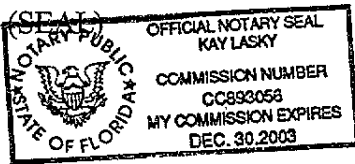
