# ARTICLES OF INCORPORATION OF COMNET DIAGNOSTICS, INC.

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, adopts the following Articles of Incorporation.

## ARTICLE I. NAME The name of the corporation is COMNET DIAGNOSTICS, INC.

#### ARTICLE II. PRINCIPAL OFFICE
