ARTICLES OF INCORPORATION

The undersigned, acting as the incorporator of the corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation:

ARTICLE I

NAME: The name of the corporation is CHEM-DRY BY TURNER, INC.

ARTICLE II

REGISTERED OFFICE AND REGISTERED AGENT: The street address and telephone number of the initial registered office is 3545 THOMAS STREET, JACKSONVILLE, FLORIDA 32205, (904) 388-8682.

The name of the initial registered agent is ROBERT E. TURNER III, who is familiar with the accepts of the duties and responsibilities as Registered Agent for said Corporation.

PRINCIPAL OFFICE AND ADDRESS is the same as the REGISTERED OFFICE.

DURATION: The corporation shall have a perpetual existence.

ARTICLE VI

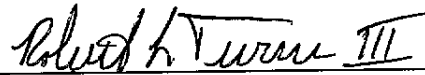
BOARD OF DIRECTORS: The initial board of directors shall consist of one (1) member. The name and address of this person who is to serve as director is as follows:

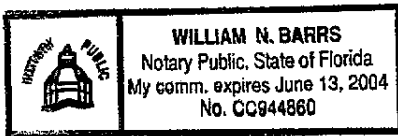
