## ARTICLES OF INCORPORATION OF PEPPERCORN GRILL, INC.

The undersigned, for the purpose of forming a corporation under the Florida Generation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I - NAME

The name of this corporation is PEPPERCORN GRILL, INC. The mailing address of the corporation is 1131 Washington Avenue, Miami Beach, Florida 33139.

#### ARTICLES II - PURPOSE

The purpose of the corporation is to engage in any lawful act or activity for which corporations may be organized under the laws of Florida and the United States.

#### ARTICLE III - DURATION

This corporation shall have perpetual existence commencing on the date of execution and acknowledgement of these Articles of Incorporation.

#### ARTICLE IV - CAPITAL STOCK

This corporation is authorized to issue 1,000 shares of \$1.00 par value Common Stock which shall be designated "Common Shares".

#### ARTICLE V - PREEMPTIVE RIGHTS
