ARTICLES OF INCORPORATION

OF

COLUMN ON TO STATE OF THE STATE The undersigned, being a natural person, does hereby act as incorporate the following Articles of Incorporation for the purpose of organizing a business corporation pursuant to the provisions of the Florida General Corporation Act.

FIRST: The name of the corporation (hereinafter called the "Corporation") is SHAGGY ENTERPRISES, INC.

<u>THIRD</u>: The duration of the Corporation shall be perpetual.
