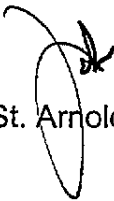

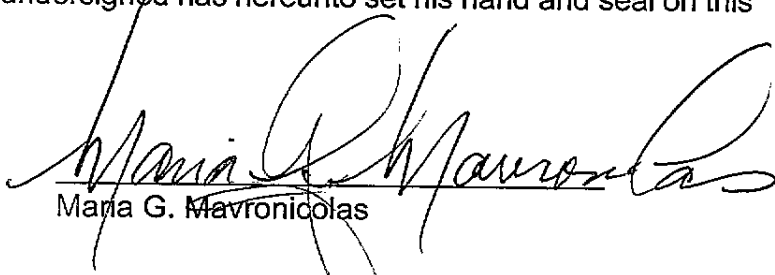
ARTICLE XI CUMULATIVE VOTING

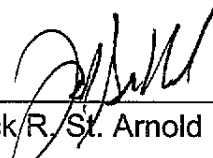
