CERTIFICATE OF INCORPORATION

OF

Computer Support On-Site, Inc.

We, the undersigned, each a natural person competent to contract, do hereby associate ourselves together for the purpose of forming a corporation for profit under the laws of the State of Florida, in accordance with the following Certificate of Incorporation.

ARTICLE I

The name of this corporation shall be Computer Support On-Site, Inc.

ARTICLE II

The general nature of the business to be transacted by this corporation is **computer repair**. To engage in any activities or business permitted under the laws of the United States and of this State, except that it shall not engage in the railroad, canal, telephone, or telegraph business.

ARTICLE III

The maximum number of shares of stock that this corporation is authorized to issue and have outstanding at one time shall be **1000** shares of common stock having a nominal or par value of **\$1.00** per share. The consideration to be paid for each such share shall be money, property, or service of value at least equivalent to the stock issued as fixed and determined from time to time, by the Board of Directors. Any and all shares without par value so issued, the full consideration for which as fixed has been paid or delivered, shall be deemed fully paid stock and shall not be liable to any further call or assessment thereon. The holders of such shares shall not be liable for any further payments in respect to such shares.

ARTICLE IV

The amount of capital with which this corporation will begin business shall not be less than Five Hundred (\$500.00) Dollars.

ARTICLE V

The duration of the corporation shall be perpetual.

ARTICLE VI

The initial post office address of the principal office of the corporation in the State of Florida shall be 3604 2nd Drive North East, Bradenton, FL 34208, but this corporation shall have the power of transacting business at such other place or places as the Board of Directors may designate, and it may establish branch offices or places of business in such places within or without the State of Florida as the Board of Directors from time to time may direct.

ARTICLE VII

The corporation shall have a board of directors of 2 persons initially. The number of directors may be increased or diminished from time to time by By-Laws adopted by the stockholders of the corporation, but shall never be less than 1.

ARTICLE VIII

ARTICLE X


The director(s) and stockholder(s) shall have the power to hold their meetings and to


