**ARTICLE I**

**Name and Location**

1.1. The name of the corporation is **OMEGA CONSULTING SERVICES, INC.** The mailing address of the corporation is 7933 Club Boulevard, Largo, Florida 33777.

**ARTICLE II**

**Duration**

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.

**ARTICLE III**

**Purpose**






