ARTICLES OF INCORPORATION

OF

ARTICLE I

Name and Location

1.1. The name of the corporation is **OMEGA CONSULTING SERVICES**, **INC.** The mailing address of the corporation is 7933 Club Boulevard, Largo, Florida 33777.

2.1 This corporation shall have perpetual existence commencing on the date of filing of these Articles of Incorporation with the Department of State of Florida.
