

**ARTICLES OF AMENDMENT
TO
ARTICLES OF INCORPORATION OF
JSR INVESTMENT PROPERTIES, INC.**

Article III of the Articles of Incorporation of JSR Investment Properties, Inc., a Florida corporation ("Corporation"), were amended by the Corporation's Board of Directors and approved by a majority of the shareholders of the Corporation on May 2, 2012. The Corporation is filing these Articles of Amendment to Articles of Incorporation pursuant to Florida Statutes 607.1006.

1. Article III of the Articles of Incorporation was amended in its entirety as follows:

"Article III


The total number of shares of capital stock authorized to be issued by the Corporation shall be one million (1,000,000) shares having a par value of One Dollar (\$1.00) per share. Each of the said shares of stock shall entitle the holder thereof to one (1) vote at any meeting of the Shareholders. All or part of said capital stock may be paid for in cash, in property or in labor or services at a fair valuation to be fixed by the Board of Directors at a meeting called for such purpose. All stock when issued shall be paid for and shall be nonassessable."

2. The foregoing Amendment to the Articles of Incorporation was duly adopted by all of the Directors of the Corporation on May 2, 2012.

3. The above Amendment to Article III of the Articles of Incorporation was approved by the consent of a majority of the shareholders of the Corporation in accordance with Florida Statutes Section 607.0704 on May 2, 2012, which consent was sufficient for the adoption of these Articles of Amendment by the Corporation.
