### ARTICLE I NAME

The name of this Corporation is PROPULSION SYSTEMS INTERNATIONAL, INC. The address of the Corporation is 2518 Cozumel Drive, Tampa, FL 33618.

### ARTICLE II DURATION

This Corporation shall have perpetual existence.

## ARTICLE III NATURE OF BUSINESS

This Corporation is being formed for the following purposes:

To conduct any and all business activities permitted by the laws of the State of Florida.
