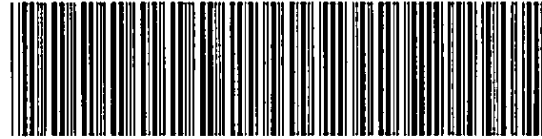

AMENDMENT TO ARTICLES OF INCORPORATION**

The Shareholders and Board of Directors of Realtech Services, Inc., unanimously approve the following amendments to the Articles of Incorporation of the business:

Article III is amended as follows:

“The number of shares of stock that this corporation is authorized to have outstanding at any one time is 100 shares at \$1.00 par value.” is deleted and replaced with: “The number of shares of stock that this corporation is authorized to issue and have outstanding at any time is 200,000 (Two Hundred Thousand) shares. Upon amendment of this Article to read as set forth, each outstanding share of the corporation at the time of this amendment is divided into 1,000 (One Thousand) shares.”

and

There shall be added an Article IX as follows:

“The transfer of shares of this corporation may be restricted by the terms of a shareholder’s agreement or the Bylaws, a copy of which will be provided to bona fide transferees on request.”
