ARTICLES OF INCORPORATION OF


#### ARTICLE VIII - INDEMNIFICATION

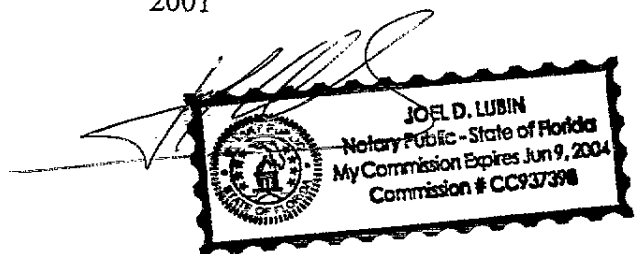


