NAME

ARTICLE II

PRINCIPAL OFFICE

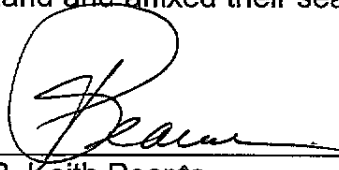

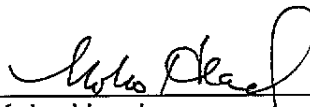
