During the third week of March 2003, I mailed the 2003 UBR with check number 1268 for \$158.75 covering the UBR fee plus the Certificate of Status fee.

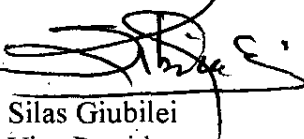
