ARTICLES OF INCORPORATION

The undersigned, acting as incorporator of a corporation under the Florida FLORIDA General Corporation Act, adopts the following Articles of Incorporation for such Corporation:

- 1. The name of the Corporation is: Odalys Valenzuela, D.D.S., P.A.
- 2. The mailing address for the Corporation shall be 27 Tamiami Canal Road, Apt. 1, Miami, FL 33144.
 - 3. The period of its duration is perpetual.
- 4. The Corporation may engage in rendering to the public such professional services as are usually rendered by Doctors of Dentistry. Such professional services shall be rendered through officers, employees and agents who are duly licensed to practice dentistry in accordance with the laws of the State of Florida.

The Corporation may invest its funds in real estate, mortgages, stocks, bonds, or any other type of investment and own real or personal property necessary for the rendering of professional services and may engage in any other activity permitted of licensed dental practitioners under the Professional Service Corporation Act, the laws of the United States and Florida.

- 5. The Corporation shall have authority to issue 5,000 shares, all of one class, \$1.00 par value.
- 6. The address of its initial registered office is 2801 Ponce de Leon Blvd., Suite 1155, Coral Gables, Florida, 33134, and the name of its initial registered agent at said address is John T. Prahl.
- 7. The number of directors constituting its initial board of directors is one (1), whose name and address is:

The preemptive right of any holder is determined by the ratio of the authorized (authorized and issued) shares of common stock held by the holder to all shares of common stock currently authorized (authorized and issued).
