ARTICLES OF INCORPORATION OF 3 TIMES, INC.

ARTICLE I

The name of this corporation is 3 TIMES, INC.

ARTICLE II

This corporation shall have perpetual existence commencing on the date of the filing of these Articles of Incorporation.

ARTICLE III

This corporation is organized for the purpose of transacting and engaging in any and all activity or business permitted under the laws of the State of Florida or of the United States.
