Name and Address

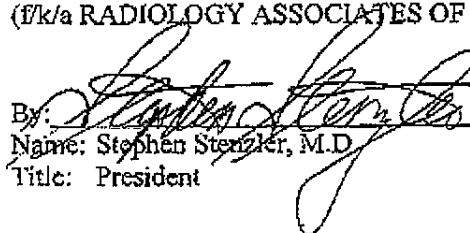
