TO THE
ARTICLES OF INCORPORATION
OF**

RADIOLOGY ASSOCIATES OF TAMPA, INC.

Pursuant to the provisions of Section 607.1006, Florida Statutes, this Florida corporation (the "Corporation") adopts the following Articles of Amendment to its Articles of Incorporation:

1. Article I of the Articles of Incorporation of the Corporation is amended to read as follows:

"ARTICLE I

Name and Address

The name of the corporation is **Radiology Associates of Tampa, P.A.** The Corporation's principal office and mailing address is 511 West Bay Street, Suite 301, Tampa, Florida 33606."

2. Article III of the Articles of Incorporation of the Corporation is amended to read as follows:

"ARTICLE III

The purpose for which this corporation is organized is to provide radiology oncology and other related medical services."

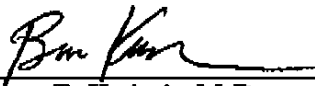
