ARTICLE I - NAME

The name of this corporation is JAHF, INC.

ARTICLE II - ADDRESS

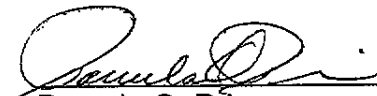
