Re: Uniform Business Report and Filing Fee

In August 2001, as a sole proprietor, I/created an S-Corporation. However, to keep my records as simple as possible, I did not begin to use the Corporation until January 1, 2002.

Since I did not use the Corporation at all in 2001, it wasn't until 2002 that my assistant began to research the tax filing requirements of an S Corporation and found out about the Uniform Business Report (UBR). Upon calling the phone number listed online for more information about the filing requirements, she was told that we should have filed a UBR for 2001 because the corporation was in existence, even though we did not use it. She was also told that the filing fee had increased as of May 1 to \$550 from \$150, but that we should immediately submit a UBR with \$150 and this letter explaining why we are filing late.

I hope that you will accept this letter and the lower fee of \$150 since we did not realize that we would have to file any forms before we began to officially use the corporation.
