**ARTICLES OF INCORPORATION**

*THE UNDERSIGNED* incorporated hereby makes, subscribes, acknowledges and files with the Department of State this corporation for profit in accordance with the law of the State of Florida.

**ARTICLE I  
NAME OF CORPORATION**

The name of the corporation shall be:

NATURE OF BUSINESS**
