# ARTICLES OF INCORPORATION OF ROZENTAL JEWELERS INC.

#### ARTICLE ONE

The name of this corporation is: ROZENTAL JEWELERS INC.

The principal office and mailing address of this corporation is: 1840 WEST 49TH STREET, STE. #404, HIALEAH, FL. 33012

#### ARTICLE TWO

#### NATURE OF BUSINESS

This corporation may engage in any activity or business related that are permitted under the laws of the United States of America and the laws of 4the State of Florida.

#### ARTICLE THREE

#### DURATION

This corporation shall have perpetual existence unless sooner dissolved in accordance with the laws of the State of Florida. The date on which corporate existence shall begin is: UPON APPROVAL BY SECRETARY - OF STATE.

#### ARTICLE FOUR

#### CAPITAL STOCK

This corporation is authorized to issue shares of stock as follows:

- F- Voting Rights. Each share of Common Stock shall entitle the -- record holder thereof to one vote upon each proposal presented at meetings of the stockhoders of the corporation.

#### BY LAWS
