The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

ARTICLE I. NAME

The name of the corporation shall be JY5, Inc.

The incorporator to these Articles is Yolanda N. Aurelio, 8141 Westborne Drive, Pensacola, FL 32506.


ARTICLE VII. DIRECTORS


