

ARTICLES OF INCORPORATION OF
Royale Jade Trading Corporation
ARTICLE I.

SECRETARY OF STATE
TALLAHASSEE, FLORIDA

CORPORATE NAME

The name of this corporation shall be: Royale Jade Trading Corporation

ARTICLE II. NATURE OF CORPORATE BUSINESS

The Corporation may engage in any activity or business permitted under the laws of the United States and the State of Florida.

ARTICLE III. CAPITAL STOCK

This Corporation is authorized to issue a maximum of One Thousand (1,000) shares of common stock having a par value of One Dollars (\$1.00) per share. The consideration to be paid for each share of stock shall be fixed by the Board of Directors.

The name and post office address of the first Director of the Corporation is:


