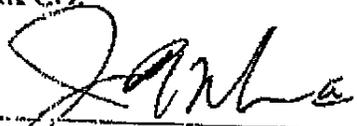
ARTICLE VII

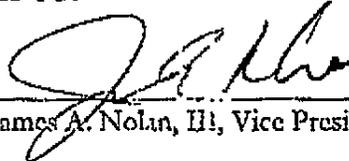
